_____ Male Cat Neuter: \$49 (There will be a \$20 charge added for cryptorchid males)

_____ Feline Leukemia/FIV test (results take 24 hours): \$30

_____ FVRCP vaccine(Feline Distemper): \$15 (will require a booster in 3 weeks if first time)

_____ Leukemia vaccine: (FeLV) \$20 (will require a booster in 3 weeks if first time)

_____ Rabies Vaccine 1 yr: \$15 (required unless proof of current Rabies vaccine is shown)

_____ Microchip implantation: \$30 (with FREE lifetime registration)

_____ Flea or Ear Mite treatment (dose of Revolution) \$18 and (a dose of Capstar) \$7 (will be done automatically if fleas or mites are found)

_____ Tapeworm treatment injection: \$20 (will be done automatically if worms are seen)

_____ Cardboard carrier: \$10 (required if more than one cat is present in a single carrier)

_____ Pain medication: \$22 (given as an extra injection prior to recovery)

_____ Left ear tip for feral cats: NO CHARGE

Call to make an appointment. If you are having difficulty trapping/catching the cat, we can work with you on scheduling but you must call to discuss it with us. Print and fill out this form to bring it with you on the day of your appointment or you can fax/email it to us ahead of our scheduled day. Drop-off is between 8-9am and pick up is between 4-6:30pm. **(call us after 4pm to confirm your total charges and pickup time)** Animals must be presented in individual carriers or traps and may not be left overnight unless prior arrangements are made. Boarding charges will apply. **A deposit equal to the charge for services will be required when you drop off.** Any remaining balance will be due in full in cash upon pick up. If parasites are found, the cat WILL be treated automatically at your expense.

This is a low-cost spay/neuter clinic for feline population control purposes. It is intended for cats that are feral, stray or in the care of a rescue agency and is priced accordingly. Individuals with owned or indoor pet cats are not eligible for this program. It is strongly recommended that those cats are seen by a regular veterinarian.

I understand the risks that are inherent with any anesthetic procedure. I hereby release Hanover Veterinary Hospital, as well as its employees and affiliates, from all liability and waive my right to any and all claims for damages, including death, of the above animal. I agree to all of the above payment policies. I understand that failure to abide by the above payment policies will forfeit my discount and result in full pricing being assessed on all procedures performed. I will be responsible for these charges upon pickup. ***I understand that abandoning animals will be ground for legal action and/or prosecution.***

INSTRUCTIONS

1. Do not feed the cat any later than midnight the night before coming to the hospital. You may provide water up until the time you bring the cat in.
2. Bring a deposit. Services must be prepaid. We accept cash, credit card or debit card. **NO CHECKS**. A \$2 discount is offered for cash payments.
3. Do not bring any personal items. The return of collars (including flea collars), leashes, harnesses or tags cannot be guaranteed, as all of these will need to be removed prior to surgery. Please **DO NOT** put blankets, towels, or any other soft items in the carrier. These pose a **SUFFOCATION HAZARD** and any such items left in the carrier will be removed. Cats will be recovered in a warm, dry environment to help prevent hypothermia.

AFTER SURGERY CARE

1. Sutures are placed under the skin and are completely absorbable. There are no sutures to remove.
2. Keep the cat in a clean, room-temperature environment until eating and drinking normally. Avoid releasing cats directly into temperature extremes (freezing winter temps/hot humid weather)
3. For cats that live in barns or outdoors, we recommend providing a clean sheltered area for a day or two to allow the cat to recover and begin eating and drinking normally again.
4. You may provide water and food as soon as the cat is released from our clinic.
